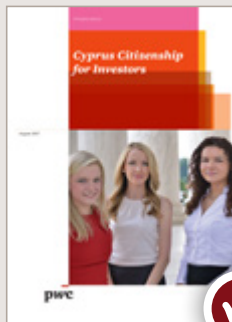
## Why Cyprus
