Following our Newsletter N-5-2025, the Cyprus Tax Authorities (CTA) issued the [attached](#) announcement on 20 August 2025 informing the taxpayers that as from Friday 22 August 2025, the submission of the (Employer) Return for Withheld Tax and Contributions (TD7) and the payment of PAYE will be made exclusively through TFA.

In detail

Following our Newsletter N-5-2025, the Cyprus Tax Authorities (CTA) issued the [attached](#) announcement on 20 August 2025 informing the taxpayers that as from Friday 22 August 2025, the submission of the (Employer) Return for Withheld Tax and Contributions (TD7) and the payment of PAYE will be made exclusively through TFA.

Annual TD7 (year 2024)

- Submission deadline: 31/12/2025
- TIN is not required for each employee

Monthly TD7 (year 2025)

- The submission of all monthly TD7 for 2025 is **mandatory as from January 2025**, even for the months **already** paid via Tax Portal
- TIN is **required** for each employee
- Monthly TD7 submission deadlines:
 - January-November 2025: 31/12/2025
 - December 2025: 31/01/2026
- Withheld Tax and Contributions payment deadlines:
 - June-November 2025: 31/12/2025
 - December 2025: 31/01/2026

Any **interest and charges** previously calculated, will be **automatically recalculated in TFA**, taking into account the aforementioned extensions.
