

Cyprus has two main airports:

Larnaca International Airport: An international airport located 4 km southwest of Larnaca. Larnaca International Airport is Cyprus' main international gateway.

Paphos International Airport: Located 6.5 km southeast of the city of Paphos, Cyprus.

The map below illustrates the exact locations of the airports mentioned above.



Cyprus Connectivity

Cyprus is considered a regional transit hub between Europe and the Middle East. Both Airports (Larnaca and Paphos) generate a yearly passenger traffic of around 10 million passengers.

A large number of Airlines conduct flights from and to Cyprus, some of which have also established their base in Cyprus.






Cyprus has six districts:

- Nicosia (semi-occupied area)
- Limassol
- Larnaca
- Paphos
- Famagusta (semi-occupied area)
- Kyrenia (occupied area)

Nicosia is the country's capital. Nicosia and Limassol are the biggest cities and key business centers. The island is divided by the UN Buffer Zone and the northern part is occupied by Turkey.

Below are some indicative travel distances from Nicosia/Limassol to the other cities:

- Nicosia to Limassol 85 km
- Nicosia to Larnaca 45 km
- Nicosia to Paphos 148 km
- Nicosia to Famagusta 82 km
- Limassol to Larnaca 69 km
- Limassol to Paphos 67 km
- Limassol to Famagusta 109 km

Cyprus as a headquartering/ business base

Why is Cyprus an appealing headquartering base?

Historically Cyprus has been attracting international companies that seek to have an alternative base in the region.

Increasingly over the last few years, we see even more groups choosing Cyprus to be their headquartering base to host large numbers of staff, or setting up substance on the island. This includes relocation of staff at all levels, including senior management staff, and even in some cases, relocation of the ultimate beneficial owner(s) and their families. Moving to Cyprus -Immigration Requirements

Entering Cyprus

Holders of valid double or multiple entry Schengen visa or a Bulgarian / Croatian / Romanian national visa, as well as residence permits issued by Schengen Member States or by Bulgaria, Croatia and Romania, are not required to hold a short-stay visa to enter the Republic of Cyprus for a time period that does not exceed 90 days in any 180 day period (Citizens of Turkey and Azerbaijan have to follow the regular visa issuance procedure).

Third Country Nationals ('TCNs') of specific nationalities may travel to Cyprus without further entry requirements for a short stay up to 90 days (for the full list of nationalities, please refer <u>here</u>.

A Third Country National ('TCN') can also apply for a visa at a relevant Cyprus Embassy abroad. The said visa can be used to enter Cyprus.

An entry permit can be granted to TCNs who wish to enter Cyprus and commence employment right away (and consequently complete all formalities for their Temporary Residence and Employment Permit).

Residing in Cyprus

Employment of Third Country Nationals

A Cyprus registered Company whose majority shareholding belongs to TCN Ultimate Beneficial Owner/s (UBO/s) or which is a listed Company, is considered a Company of Foreign Interests and can employ TCN highly skilled employees in Cyprus after completing a one-off 'company eligibility process'. Such an application is submitted to and reviewed by the Business Facilitation Unit, under the Ministry of Energy, Commerce and Industry. The Competent Authority for the review of applications and issuance of Residence Permits is the Civil Registry and Migration Department, under the Ministry of Interior.

As part of the company eligibility application, the Company needs to deposit the amount of at least €200.000, in its local bank account at a credit institution licensed by the Central Bank, supported by the relevant Bank SWIFT or other similar document proving a foreign direct investment by the UBO/s, legally admitted to Cyprus from abroad. Additional requirements for this process, include showing substance in Cyprus by owning or renting an office space in Cyprus etc.



Employment of TCN staff who are not highly skilled employees (as described in the next section), or who are employed by a company of EU interests, are subject to a different application process via the Ministry of Labour, and subsequently the Civil Registry and Migration Department.

Temporary Work and Residence Permits

- A Cyprus registered company of foreign interests that became eligible to employ TCN staff, can employ highly skilled TCN personnel earning a salary over €2.500 gross per month;
- Such a Company can also employ support TCN staff earning less than €2.500 gross per month (with pre-approval from the Ministry of Labour);
- Up to 70% of the total number of the Company's employees can be TCNs (over a period of 5 years);
- The Permit for employment of highly skilled TCNs can be issued with a validity of up to 3 years and can be renewed upon expiration;
- The TCN highly skilled employees can legally take up employment in Cyprus from the moment their Permit application is accepted by the Civil Registry and Migration Department and the relevant receipt is issued. In the case of an Entry Permit, legal employment can be taken upon entry to Cyprus;
- The Permit becomes void if the TCN holder is out of Cyprus for more than 3 continuous months;
- The applicants must be present during the application submission. Finger prints, electronic signature and photograph of applicants will be taken as biometric elements;
- The family members of the high skilled TCN employees can also relocate to Cyprus and obtain the relevant Temporary Residence Permit, as Dependants of the employee. The spouse of the TCN employee has free access to the labor market under the Family Reunification - employment status (provided they have been married for at least 1 year and find a relevant employer);
- Non married spouses and parents of the employee/sponsor can also relocate to Cyprus under a Temporary Residence Permit (Visitor status)

Permanent Residence Category 6.2

Regulation 6(2) of the Cyprus Aliens and Immigration Regulations, (4rd revision, 02 May 2023) enables Third Country Nationals who wish to permanently relocate to Cyprus to apply for a Permanent Residence Permit that will grant the right to reside in Cyprus. In addition to meeting the financial conditions set in the policy in relation to minimum investment and sources of income from abroad, the applicant and family members must fulfil other conditions such as hold a clean criminal record, medical insurance etc. The permit can be revoked if certain conditions are not met.

Key Information for EU Nationals

Within 4 months from the last entry to Cyprus, European Union citizens who wish to take up residence in Cyprus, need to obtain an EU Registration Certificate

Long Term and Permanent Residence Permit for Employment

- Long term residence permit is granted to individuals who have resided legally and continuously in Cyprus for a period of at least 5 years;
- Applicants should have a work permit in Cyprus and adequate income from employment and suitable accommodation for themselves and their dependents;
- An employment contract of at least 18 months' or open duration should be held by applicants. Applicants should hold the required Certificate of knowledge of the Greek language;
- A Long Term Residence Permit has a 5-year duration and is renewable. The application processing usually takes 12-18 months and applicants are informed of the outcome in writing;
- Cyprus also provides for a Permanent Residence Permit for employment (Category E), which is linked to a specific employer and position. It is granted to TCN employees holding senior management positions or very highly specialized positions. The application processing usually takes 12-18 months and applicants are informed of the outcome in writing.



Cyprus Citizenship

Citizenship by naturalization based on years of residence

- TCNs can apply to be naturalized as Cypriots if they have completed 7 years of legal residence in Cyprus;
- EU nationals, or TCN's who hold a Long term or a Permanent Residence Permit, or who are either parents or children of Cypriot citizens, they may apply for the Cyprus citizenship upon completion of 5 years of residence in Cyprus;
- Applicants must have resided legally and continuously in Cyprus during the twelve months preceding the date of the application.

Cyprus Citizenship as a spouse of a Cypriot citizen

Foreign spouses (EU Nationals and TCNs) of Cypriot Nationals, who have been married for 3 years and have completed 2 years of residence in Cyprus, prior to the date of the application, may apply for the Cyprus Citizenship.

An application for the acquisition of the Cyprus Citizenship can be submitted by spouses of overseas Cypriots after they have completed at least three years of marriage. These applications must additionally be accompanied by a letter from the couple stating the reasons for requesting the grant of the Cypriot citizenship to the foreign spouse. If the couple has completed at least five years of marriage and has at least one child, it is not necessary to attach the aforementioned letter. Such applications can be submitted via a Cyprus Embassy / Consulate abroad.

In addition to the minimum time spent, one must also fulfill all the required conditions.





Tax Facts and Figures

Basis of Taxation

Individuals who are tax residents in Cyprus are taxed on their worldwide income i.e. on all income accrued or derived from all sources in Cyprus and abroad irrespective of whether this income is actually remitted to Cyprus or not.

Tax resident individuals whose **domicile is not in Cyprus** are exempt from Special Defence Contribution which is a tax that applies on dividend income, 'passive' interest income and rental income from sources in Cyprus and abroad. Foreign nationals coming to live and work in Cyprus are expected to fall in this category.

Significant tax exemptions apply on income from employment of foreign individuals who take up residency in Cyprus.

Tax residence of an individual in accordance with the Cyprus tax legislation

An individual is considered tax resident in Cyprus if he/she spends in Cyprus more than 183 days in any calendar year (same as the tax year).

A second tax residency test, the "60 day rule", has also been introduced effective as from 1 January 2017.

As such, from the tax year 2017 onwards, an individual is considered a tax resident of Cyprus if the individual satisfies either the "183 day rule" and/or the new "60 day rule" for the tax year.

The "60 day rule" applies to individuals who in the relevant tax year:

- 1. do not reside in any other single state for a period exceeding 183 days in aggregate, and
- 2. are not considered tax residents in any other state and
- 3. reside in Cyprus for at least 60 days and
- 4. have other defined Cyprus ties. To satisfy this condition the individual must carry out business in Cyprus and/or are employed in Cyprus and/or hold an office (director) of a company tax resident in Cyprus at any time in the tax year, provided that such is not terminated during the year and maintain in the tax year a permanent residential property in Cyprus which is either owned or rented by him/her.





Days in and out of Cyprus are calculated as follows and apply to both the "183 day rule" and the "60 day rule":

- the day of departure from Cyprus counts as a day of residence outside Cyprus;
- the day of arrival in Cyprus counts as a day of residence in Cyprus;
- arrival and departure from Cyprus on the same day counts as one day of residence in Cyprus;
- · departure and arrival in Cyprus on the same day counts as one day of residence outside Cyprus

Personal Income Tax

The following income tax rates apply to individuals:

Foreign pension income is taxed at the flat rate of 5% on amounts over \in 3.420. The taxpayer can however on an annual basis elect to be taxed at the normal tax rates and bands set out above.

Exemptions

* For expatriates living in Cyprus under the non-domiciled regime, such dividend and interest income are exempt both from Income Tax and Special Contribution for Defence (see subsequent Special Defence Contribution section).

** The term "Securities" includes, amongst others, shares, bonds, debentures, founders' shares and other securities of companies or other legal persons, incorporated in Cyprus or abroad.

- Interest income (except interest arising from the ordinary business activities or closely related to the ordinary business activities of an individual)*
- Dividend income*
- Employment income (see below)
- 90 Days rule: The whole amount of remuneration from salaried services rendered outside Cyprus for more than 90 days in a tax year to a non-Cyprus resident employer or to a foreign permanent establishment of a Cyprus resident employer
- The whole amount of lump sum received by way of retiring gratuity, commutation of pension or compensation for death or injuries
- The whole amount of capital sums accruing to individuals from any payments to approved funds (e.g. provident funds)
- The whole amount of profits from the sale of securities **
- Individuals who relocate and exercise first employment in Cyprus, could apply for a period of 7 years, starting from the tax year following the tax year of commencement of employment. Individuals granted the above 50% exemption will not be eligible for this exemption.
- Individuals that were eligible to claim the 20% or 50% exemptions that applied pre-1 January 2022 may continue to claim the said exemption for any remaining period if they are not eligible to claim the exemption for employment commencing as from 1 January 2022. The 20% and 50% exemptions that applied pre-1 January 2022 were available for a total period of 5 or 10 years respectively for each individual.

 $\langle \uparrow \rangle$

• Commencing as from 1 January 2022, with annual remuneration exceeding €55.000 per annum, should be able to enjoy an exemption from income tax for 50% of their remuneration. For each individual the exemption will apply once in their lifetime for a period of 17 years. Certain conditions apply, for example the individual should not be tax resident in Cyprus for a period of 10 consecutive tax years immediately prior to the year of commencement of the employment in Cyprus. Subject to certain conditions, individuals whose employment commenced prior to 1 January 2022, may also be eligible to claim the exemption (see below).

The effective tax rate for individuals earning circa €55.000 may be as low as 3%.

Tax Deductions

The following are deducted from income:

Expenditure of revenue nature for scientific research and for research and development, subject to conditions	The whole amount (and for expenditure incurred in years 2022, 2023 and 2024, an additional 20%).
Tax amortisation on any expenditure of capital nature for scientific research and research and development,subject to conditions	The whole amount (and for expenditure incurred in years 2022, 2023 and 2024, an additional 20%) allocated over the lifetime of the asset (maximum period 20 years).

Social Insurance Contributions

As from 1 January 2019, and for the next five years, the rate of 8,3% applies to both the employer and the employee. Thereafter, the rate will increase every five years by 0,5% until it reaches 10,3% as from 1 January 2039. The maximum level of emoluments for 2023 is as follows:

Employers should also make contributions to certain other public funds.

As from 1 January 2019 the contributions of self-employed persons are 15,6% of their income. Thereafter, the rate will increase by 1% every five years until it reaches 19,6% as from 1 January 2039. The amount of the contributions is subject to a lower and a maximum limit, depending on the profession or trade of the Self-Employed Person.



Special Defence Contribution ('SDC') on dividends, interest and rental income

Special Defense Contribution ("SDC") is imposed on dividend income, "passive" interest income (except for interest arising from the ordinary business activities or closely related to the ordinary business activities of an individual) and rental income earned by individuals who are both Cyprus tax resident and Cyprus domiciled.

An individual is domiciled in Cyprus for the purposes of Special Contribution for Defence if (s)he has a domicile of origin in Cyprus per the Wills and Succession Law (with certain exceptions) or if (s)he has been a tax resident in Cyprus for at least 17 out of the 20 tax years immediately prior to the tax year of assessment. Anti-avoidance provisions apply.

The domicile of origin is the domicile of the father of the individual at the point that the individual was born.

As mentioned above, TCNs coming to live and work in Cyprus are expected to be considered as non-domiciled and will therefore be exempt from SDC on such dividends, interest and rental income.

*Interest income earned by individuals from corporate bonds (as from 26 June 2019), Cyprus government savings and development bonds as well as all interest earned by a provident fund is subject to Special Contribution for Defence at the rate 3% (instead of 30%). ** Rental income is reduced by 25% and then taxed at 3%. Rental income is also subject to personal income tax.

Foreign taxes paid can also be credited against the Special Contribution for Defence liability.

General Health System

As per General Health System Law of 2001 (89(I)/2001 as amended 2017, a general health system was introduced in Cyprus aiming to provide to the population equal access to a holistic health care system. Patients will have the option to select a health care provider from the private as well as the public health care sector.

Contributions relating to the implementation of the General Health System (NHS) started on 1 March 2019, and the current rates are as per the table below:

*Relates to holders of public or local authority office or other office, the income out of which does not come within the scope of (i) or (iii) or (iv) of (vii). GHS contributions are capped at €180.000 total annual incomes.



Capital Gains Tax

Capital Gains Tax is imposed (where the disposal is not subject to income tax) at the rate of 20% on gains from the disposal of immovable property situated in Cyprus including gains from the disposal of shares in companies which directly own such immovable property.

Further, as from 17 December 2015 gains on the disposal of shares of companies which indirectly own immovable property located in Cyprus and at least 50% of the market value of the said shares derive from such immovable property are subject to Capital Gains Tax. In the case of share disposals only that part of the gain relating to the immovable property situated in Cyprus is subject to CGT.

Disposal for the purposes of Capital Gains Tax includes amongst others, exchange, leasing, gifting, abandoning use of right, granting of right to purchase, and any sum received upon cancellation of disposals of property.

Shares listed on any recognised stock exchange are excluded from these provisions.

Certain disposals of immovable property are not subject to Capital Gains Tax and include amongst others, transfers arising on death, gifts made from parent to child or between husband and wife or between up to third degree relatives, gifts to approved charities and the Government, gifts to/from family companies (subject to conditions), expropriations etc.

Subject to conditions, land as well as land with buildings, acquired at market value in the period 16 July 2015 up to 31 December 2016 will be exempt from Capital Gains Tax upon its disposal.

Individuals can deduct from the capital gain a lifetime exemption subject to an overall lifetime maximum of €85.430 (subject to conditions).

Inheritance Tax

Cyprus does not levy any Inheritance tax.

Levy on Cyprus property disposals

As from 22 February 2021 a levy of 0,4% applies on all disposals of immovable property that are within the current control of the Republic (i.e. both trading-nature and capital-nature disposals).

As from 18 November 2022, the levy applies on all disposals of immovable property as well as disposals of shares of a company which, directly or indirectly, holds immovable property (1).

In cases involving a direct disposal of immovable property, the levy is imposed on the disposal consideration, whereas in cases involving a disposal of shares of a company the levy is imposed on the latest general valuation undertaken by the Department of Land & Surveys.

The obligation for payment of the levy lies with the seller.

The following direct or indirect disposals of immovable property are exempt:

- Debt for asset swaps;
- Qualifying reorganisations; and
- Shares listed on a recognised stock exchange.

(1.) During the period 22 February 2021 – 17 November 2022, different provisions applied with respect to certain aspects of the levy. For example, during this period the levy is applied only on disposals of immovable property itself and disposals of shares of a company which directly held immovable property to the extent that the buyer of the shares assumes control of such a company.


The legal framework in Cyprus

Cyprus has an extensive network of laws and regulations which outlines and safeguards the rights of employees. As a member of the European Union, Cyprus adheres fully to EU laws relating to employment.

Employees enjoy legal protection against all forms of discrimination on the grounds of age, gender, religion, sexual orientation, disability, race and ethnicity.

A well-developed national social insurance system exists in Cyprus and employees may apply for and receive maternity and paternity allowances, sickness benefits for short-term absences from work and pensions for old age, widowhood and inability to work.

Key Features of Cyprus Employment Law

Main Rights and Benefits of Employees working in Cyprus

- Employees must be informed by their employers in writing as to the basic terms of their employment
- A minimum monthly salary exists for certain categories of employees
- Salaries must be paid at least every week, except for employees paid on a monthly basis
- The weekly working time cannot exceed 48 hours, on average, including overtime work
- Employees are entitled to at least 11 consecutive hours of rest per day
- Cyprus law provides minimum probation periods for new employees as well as a minimum notice period in the event of termination
- Employees working a 5-day working week, are entitled to 20 working days of paid annual leave in addition to the public holidays observed in Cyprus
- New mothers are entitled to a paid maternity leave of a total of 18 consecutive weeks for the first child, with additional weeks for subsequent children
- New fathers have a right to unpaid parental leave of 2 consecutive weeks, for which they may claim an allowance from the Department of Social Insurance
- Parents that have completed 6 consecutive months of employment with the same employer have a right to obtain parental leave of a maximum period of 18 weeks for each child

Acquisition of Immovable Property in Cyprus

In accordance with Cyprus Law, third country nationals may acquire immovable property in Cyprus, subject to obtaining a permission by the Cyprus Government. Such permission is not required for non-EU nationals wishing to rent real estate in Cyprus for less than 33 years.

Succession Rules in Cyprus

As a general rule, the succession of a person who (habitually) resides in Cyprus is governed, irrespective of where his assets are situated, by the succession laws of Cyprus.

By way of exception, in case of people who (habitually) reside in Cyprus and have foreign or dual citizenship, their succession could be governed by the succession laws of the country of their citizenship if they make a choice to this effect. If one does not choose, Cyprus Succession Rules will apply.

The Succession Laws of Cyprus provide for a mixed system i.e. a system which (i) recognises the right to a person to leave property by will and (ii) imposes a forced heirship system. Under this combined system, a deceased may leave part of his estate by will to whoever he wishes while the rest of his estate will end to his heirs e.g. the spouse and/ children if the deceased was married with children or other relatives if he was not. For example, in a case of a person who is married with three children the following apply:

- if he dies intestate, i.e. without a will, the surviving spouse and three children will be entitled to his estate in equal shares (1/4 each)
- if he left a will, irrespective of what the will says, the beneficiary (ies) under the will, who, may be any of his heirs or a third person, shall be entitled a to maximum 25% of his estate and the surviving spouse and the three children will be entitled to the remaining 75% in equal shares







Contracting a Civil Union in Cyprus

The Civil Union Law (184(I)/2015) (the "Law") of 2015 has entered into force on 9 December 2015, introducing the institution of the Civil Union in the Cyprus legal system.

The procedure is in effect from January 2016.

The establishment of a Civil Union takes place before the District Officer acting in his capacity as the Registrar. With the exclusion of the Adoption Law, contracting a Civil Union has respective effects and consequences as if a marriage was performed under the provisions of the Marriage Law. Any reference included in any legislation of the Republic of Cyprus to "spouse" includes also Civil Partners of a Civil Union.



Customs and Import Regulations

Household Effects

When moving to Cyprus, importing household and personal goods may require a copy of the renting contract or property purchase contract when clearing the goods from the customs office. It may be also required to attend a pre-arranged meeting at the customs office for checking the goods.

Below is an indicative list of documents required in order to import personal goods to Cyprus:

- Packing List
- Shipper's passport
- · House contract showing rental or purchase of property in Cyprus
- Letter from employer confirming employment in Cyprus
- · Letter from children's school confirming their registration

TCNs are not liable to pay import duty, excise duty or VAT on used household items and personal effects provided the following apply:

- TCN's place of residence has been outside the EU for a continuous period of at least 12 months.
- · Goods are imported within 12 months of transfer of residency
- Goods have been owned and used by the TCN in their former place of residence for at least 6 months

One must make a relevant application to obtain a relief from paying import duty, excise duty or VAT on used household items and personal effects.

Goods for which a relief is granted cannot be sold, lent, pledged, hiredout, or transferred during the 12-month period following importation.

Alcoholic and Tobacco products or articles for use as a trade or profession are not eligible for relief. Customs Examination may be required at the customs' discretion.

Duty-free Allowances

Cyprus duty free

As Cyprus is within the European Union, when travelling within the European Union, one is entitled to buy fragrance, skincare, cosmetics, champagne, wine, selected spirits, fashion accessories, gifts and souvenirs at tax-free equivalent prices. There are no allowance restrictions on these tax-free items.

If an individual is arriving from a non-EU country, the following goods may be imported into Cyprus by travellers over 17 years of age without incurring customs duty:

- 200 cigarettes or 100 cigarillos or 50 cigars or 250g of tobacco
- 1L of spirits (over 22% volume) or 2L of fortified wine or sparkling wine
- 4L of still wine
- 16L of beer
- Permissible goods in addition to the above up to the value of €430 (reduced to €175 for travellers under 15 years of age)

Banned imports

Drugs, obscene materials, flick knives, daggers, counterfeit and pirated goods, goods used for illegal hunting, firearms and ammunition.

Some restricted goods which perhaps require authorisation are plants, animals and animal products, meat, fish, cheese, honey, precious metals, hunting guns and cartridges, sporting pistols and telecommunications equipment.

Banned exports

All items mentioned above are banned from being exported. Restricted exports include antiquities and wild flora and fauna.

Car Import

A resident of another member state of the EU or a non-EU country, who would like to transfer personal property to Cyprus, under certain conditions he/she is entitled to transfer these without having to pay excise duty and VAT. Relevant information can be found in the "Guide to Customs Procedures" by following the link, www.mof.gov. cy, under section "Transfer of normal residence", as well as information on the process of applying for a relief from paying excise duty and VAT.

In case the relief application is rejected from Customs because criteria are not met for receiving a relief, one has the following options:

- to pay the excise duty and VAT (if the latter is payable);
- to place it in a customs warehouse;
- to send it to another member state of the EU; or
- to export it to a non-EU country

If part of the personal property is a motor vehicle, the individual is required to declare it to the nearest Customs Station within 24 hours from the date of its arrival. If a public holiday or weekend follows the date of arrival, he/she must make the declaration on the first business day after the expiration of the 24-hour deadline.

Customs will issue the relevant form and a copy will be given. The vehicle must be then presented, together with the relevant form and other documents relating to the vehicle, to the Inland Transport Department for inspection and registration purposes.

The maximum period of stay of the vehicle for private use in the Republic is six months per year, consecutive. If the individual wants to keep the car in Cyprus, for longer than 6 months he/she will have to register the car to the relevant authorities (Road Transportation Department) and complete the applicable process.

Conditions to be observed after importation

The car must not be sold, lent, pledged, rented, exported, transferred or disposed of in any other way without the prior approval of the Director of Customs, unless it is registered with the Road Transport Department in Cyprus. Any infringement of the aforesaid conditions constitutes an unlawful act and carries severe penalties.

Individuals who own left-wheel cars have the opportunity to import these vehicles into Cyprus. Certain processes need to be completed with the competent Authorities in Cyprus, relevant taxes must paid and the relevant conditions to be fulfilled.

Acquisition of residential dwelling

A resident of another member state of the EU or a non-EU country, who purchases/ constructs a residential dwelling in The Republic can apply for the imposition of the reduced VAT rate of 5% on its construction/ acquisition provided that certain conditions are met. That is:

- The property should be used as residential by the applicant for a period of ten years, 1.
- 2. An application for the imposition of the reduced VAT rate is filed with the Tax authorities prior to the actual delivery of the property,
- 3. The certified approval of the Tax authorities is obtained, and
- 4. The property is acquired by an applicant who is over 18 years old and did not benefit from the imposition of the reduced VAT rate for another immovable property

The reduced VAT rate of 5% is applied on the first 200 m² of the buildable area, as determined by the building coefficient of the residence.

In case the eligible person ceases to use the property for residential purposes before the lapse of a 10 year period following the acquisition, is obliged to return back to the VAT authorities the applicable VAT benefit. The VAT amount to be returned to the Tax authorities corresponds to the period that the property ceased to be used as residential.

Under the amended provisions of the VAT Law, a Taxpayer is eligible to apply for the imposition of the reduced VAT rate for another property, even before the lapse of the 10 year period, provided that it returns back to the Tax authorities all the VAT benefit obtained as a result of an acquisition of a residential property in the past.





Living in Cyprus

Finding Accommodation

There are a number of real estate agents, newspapers and search engines that provide options on rental and purchase of residential property.

A TCN can purchase a real estate property in Cyprus provided that it is within the relevant guidelines. For transfer of the title deed of a property on a TCN an approval needs to be obtained from the competent authority.

Utilities

In order be able to open an account with a utility provider to receive services, the below documents are usually required:

- Utility bill from abroad
- IBAN confirmation
- International Passport
- Rental Agreement
- Resident Permit







Heating

Most homes/indoor areas use air conditioning and/or electrical/petrol heaters and/or fireplaces.

Water in Cyprus

Each of the main cities has its own Water Board, and water is supplied to all houses. Most houses have both cold and hot water storage tanks on the roof or on a roof-high structure next to the house to provide sufficient pressure.

Hot water in most houses is heated by solar power.

The kitchens are usually equipped with hot and cold water taps that use water from the household's tank, and a mains water tap that provides cold water directly from the mains. The solar power must be turned on at least 1 hour before its used (time required may vary depending on the house heating installation).

Telephony and Internet

Telephone services are provided by the Cyprus Telecommunications Authority (CYTA), and by other private service providers (e.g. Epic, Cablenet, Primetel). Free phone directory and annual yellow pages for each district are available from the CYTA shops.

CYTA also provides broadband Internet access. Alternative providers for internet access are Epic, Cablenet, Primetel. Internet connection is achieved through broadband (DSL network, 4G, 5G) and fiber optics.

Mobile phones are widely used, with contracts with the mentioned providers. An alternative is the pay-as-you-go system, with top-up codes that can be bought online or in several shops, from €5 upwards. Phone bills are sent out monthly, electricity bills and water bills bi-monthly.

It is possible to set up direct debit payments from your bank to cover utility bills or pay via online banking. One can also pay by cash or cheque at the local offices of the utility providers.

Electricity in Cyprus

The electricity supply in Cyprus is 230 volts, a.c. 50 Hz. Sockets are usually 13 amp, square pin in most buildings. Multiple low current rating appliances may be operated from the same supply point by using an adaptor (i.e. radios, electric clocks etc.). The use of adaptors for operating high current rating appliances is not recommended (i.e. electric heaters, toasters, irons etc.). Many hotels provide adaptors upon request at the reception. Adaptors can be purchased from electric stores, supermarkets and grocery shops.

The use of photovoltaics is customary both at domestic and corporate scale.



Shopping in Cyprus

Cyprus has a number of retail shops, malls and supermarkets in all the cities. Such outlets are usually open from around 07:30am to 08:00pm from Monday to Saturday. Many supermarkets, malls and some large shops are also open on Sundays typically between 10:00am- 08:00pm.

During December, most shops extend their opening hours, sometimes operating all day on Sundays. While many retail shops observe a siesta period from 01:00pm-04:00pm from June to August, most food shops and all supermarkets stay open throughout the day. Consult the websites of these stores for detailed opening hours.

The working hours of shops are usually as follows:

- In summer, (June to August) shops are open 08:00am-02:00pm and 05:00pm-08:30pm
- In winter, business hours are 08:00am-01:00pm and 02:30pm-06:00pm (until 07:00pm/08:00pm in Spring and Autumn)

Many larger stores as well as shops in touristic areas do not close for lunch. Some shops are closed Wednesday and Saturday after 01:00pm-02:00pm, as well as all day Sunday (some exceptions apply). Many shops also cater for online shopping. The main shopping malls are located as follows:

For higher education, there are State operated Universities that offer courses in Greek and English and also a large number of private accredited universities.



As a matter of fact, the University of Cyprus (UCy) has been ranked among the top 200 universities in Europe, according to the Times Higher Education World University Rankings 2016-17. Transportation in Cyprus

Side of road

Cyprus has exactly the same road system as in the United Kingdom. Cars are driven on the left side of the road.

Road quality

Motorways and main roads are of a high standard. Inner city, smaller town and village roads are well maintained. All roads are toll free.



Speed limit

Distances and speed limits are posted in Kilometers. The maximum speed limit is 100kph (63mph) on highways, 80kph (50mph) on most other roads and 50kph (32mph) in built-up areas.



Rush hour

Rush hour in the urban areas is approximately between 07:15am-08:30am, 13:00pm-13:30pm and 14:30pm–15:30pm and during late afternoon, 17:00pm-18:30pm.



Regulations

There are strict repercussions for anyone not wearing a seat belt or crash helmet (for bikes), using a mobile phone, eating, or being under the influence of alcohol whilst driving. Children under the age of five must not sit in the front passenger seat, and must be strapped into a child seat fitted to the rear.



Gas and Petrol

Gas stations are open 24 hours a day, accepting cash or credit card. During normal working hours an attendant will pump gas for you.



Driving License

Third Country Nationals from the following Countries are allowed to drive in Cyprus using their national driving license for a period up to six (6) months:

Australia, Canada, Georgia, Iceland, Japan, Liechtenstein, New Zealand, Norway, Russia, Serbia, South Africa, South Korea, Switzerland, Ukraine, United Arab Emirates, USA, Zimbabwe

Upon expiration of the six (6) month period one must run the procedure for obtaining a Cypriot driving license or converting his/her Home Country license into a Cypriot License to comply with the relevant legislation. The responsible Authority is the Road Transportation Department and the applicant is required to be present for the application, and to bring along the following required documents, listed below, for the purpose of obtaining the local driving license:

- Utility bill from the Electricity Authority of Cyprus or Water Board of Cyprus or from social insurance, evidencing that one is residing in Cyprus for the last 6 months
- Residence Permit, Passport and ID

Converting a Foreign License into a Cyprus License

- A Third Country National who is a citizen of one of the above listed countries (or an EU Citizen) does not need to take a test in Cyprus
- The Foreign License will be converted into a Cypriot License
- In this case, the validity of the Foreign License will be revoked
- Cost €40

Obtain a Driving License in Cyprus

- If one wishes to keep the Foreign License, then he has to proceed with obtaining a CY License as well
- The individual needs to firstly obtain the learner's license
- Furthermore, the individual needs to also take the driving test
- Total cost (including learner's license + pre-booking for the test +20 driving lessons): approximately €450-550

General Information:

- All Driving Licenses are issued by the Road Transport Department
- Cyprus Driving License is valid in all EU Member States

Driving in Cyprus

Driving in Cyprus in some cases is essential as other types of transport services (i.e. bus) to remote areas of interest are not always available at frequent intervals. Four-lane motorways connect the capital, Nicosia with the coastal cities of Limassol, Larnaca and Paphos.

Parking

There is parking space throughout the city for which one can pay at parking meters or by sending a message via mobile phone. Instructions of their usage are displayed on the parking meter machines. It is not allowed to park on single or double yellow lines.



Car hire


Cyprus has car rental companies with offices in the airports and all major cities. Both national and international car rental companies are available. Cars should be reserved well in advance especially during the summer period.

Cars are available for rent with unlimited mileage, with prices ranging from €15 - €200/per day depending on the season and type of vehicle.



Drinking limit

Drivers should exercise due care over the amount of alcohol consumed. The legal limit in breath is 22 micrograms of alcohol per 100 milliliters of breath. The legal limit in blood is 50 milligrams of alcohol per 100 milliliters of blood.





There are four types of buses in Cyprus:

- **Urban buses** that link different areas within the cities and operate frequently during daytime. • In certain tourist areas, during summer period, bus schedules are extended till late in the night
- Trans-urban buses that link all towns on a daily basis and with frequent routes
- Rural buses that link almost all villages with the nearest city but with limited frequency
- Buses for airport transfers




There are three types of taxi service in Cyprus: urban, trans-urban (which are shared and can be booked), and rural. Fares are regulated by the government and all taxis have meters. Shared taxis operate every 30 minutes between major cities.

Bicycles

Cyprus encourages cycling and bicycles are available for rent from most hotels and through different locations throughout all major cities. There are bicycles paths in most major districts. It is recommended to cycle in designated paths for cycling.

Buying and owning a vehicle

There is a large variety of new vehicles from approved dealers and a variety of second-hand vehicles available for purchase from dealers.

Cars are taxed annually or every six months and must be insured. The road tax is due in January each year. Prosecutions for non-taxed cars begin in March. The fees vary depending on the size of the engine and can be paid at banks or online.

MOT periodic car inspection tests were introduced in the year 2000, starting with the very oldest vehicles still on the roads. Under relevant law every car is required to pass an MOT test.

Changing the ownership of a vehicle can be done at the Department of Road Transport (DoRT).

It is the customs regime whereby goods are placed in free circulation and consumption with relief from VAT, notwithstanding their tariff classification, provided they are transferred to Cyprus under certain conditions and for specific purposes.

This part refers to relief on private use motor vehicles which are of interest to the public when transferred within the Transfer of Normal Residence Scheme.

There is availability of hybrid and electric cars in the market as well as subsidies for electric cars.

Vehicle insurance in Cyprus

EU law states that all vehicles must have at least third party liability insurance. Local and international insurance companies operate in Cyprus that can provide various car insurance plans

In case of an accident one must call the insurance company and, depending on how serious the accident is, the police as well.

Pharmacies

Pharmacies are accessible in every neighbourhood and are open from Monday to Friday from 08:00am to 07:00pm (plus a lunch break from 13:30 to 16:00) except on Sundays. Also, they are closed on Wednesday and Saturday after 2:00pm. Designated pharmacies (assigned on a daily basis) stay open throughout the night usually until 11:00pm. After 11:00pm they are obliged by law to open in case of a need upon receiving a phone call.

Polemidia National Forest Park just outside the town of Limassol with semi- natural and natural vegetation. It offers a variety of recreational facilities such as picnic sites, hiking trails, children's playgrounds, sports grounds, cafeteria and kiosks.

Macheras National Forest Park is situated in the middle of the island, on the eastern end of the Troodos range. The Park has great historical, ecological,hydrological and recreational value. Banking in Cyprus

The Cypriot and international banks operating on the island provide a wide range of services to companies and individuals. The procedure for opening a local bank account is completed usually within 1-2 months depending on the Bank.

For international banks it might take additional time due to the review of documents being held abroad. Extensive reviews are undertaken by the bank during the account opening process with emphasis on the Source of Funds and Source of Wealth of the individuals.

Key information on the banking industry in Cyprus is as follows:

- The Central Bank of Cyprus (<u>www.centralbank.gov.cy</u>) regulates the banking sector. It publishes a list of all regulated banks, including branch and representative offices of foreign banks operating in the country
- There is a wide network of banks across the country both international and Cypriot, which employ English-speaking staff
- All major banks offer a full set of banking services for individuals and businesses: Current and savings accounts, Debit and credit cards, Direct debits and standing orders, Foreign currency exchange, Long term savings and investment accounts, loans and mortgages
- All banks offer full Internet banking services allowing all transactions to be made online. Helplines are available to support until late
- One needs to take into account compliance with domestic laws applicable to foreign Bank Accounts

All major credit cards, such as Visa, MasterCard, Diners Club and American Express, are generally accepted in restaurants, shops and in hotels.





ATMs (Automatic Teller Machines) are available 24 hours outside banks.

The amount of money that can be withdrawn per month depends on the policy of the Bank institution. Banks generally allow the withdrawal of \notin 700 - \notin 1000 cash per day.
