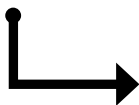



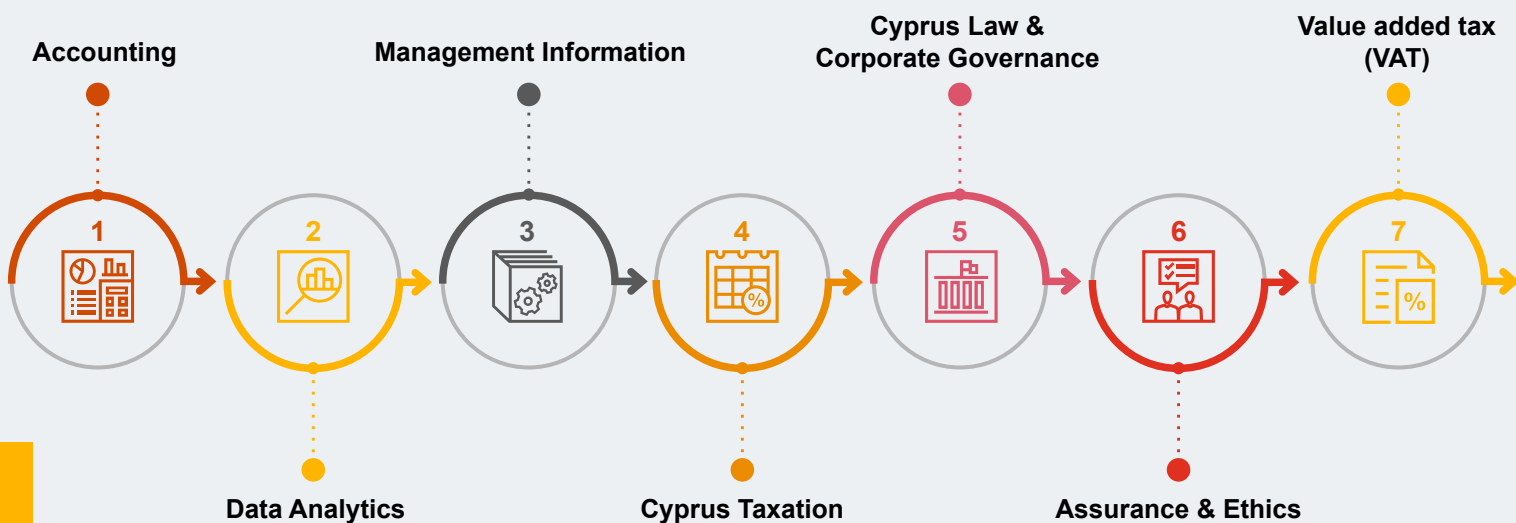


## Key facts:

- **Duration:** 21-24 months
- **Number of available modules:** 7  
*\*To obtain the BCP certificate you need to pass 6 modules*
- **Certificate Awarded:** Business Professionals Certificate  
*Note: A stand-alone certificate will be awarded upon the completion of each module. Upon completion of all 6 modules the "Business Professionals Certificate" will be awarded*
- **Optional:** After completing the Accounting, Assurance & Ethics, and Management Information modules, participants may choose to take the ICAEW relevant exams
- **Language:** English
- **Minimum entry requirement:** Completion of six (6) years of secondary education in countries where secondary education is considered equivalent to that of the Republic of Cyprus
- **Location:** Nicosia
